Police Department report was submitted by Judy Northam. Chief of Police, Ralph Sramek briefed council on activity for the month

Volunteer Fire Department report was submitted by Fire Chief, Mike Winfield. He also read report for the month of June. Reporting a total of 25 calls for the month 11 in China Grove 7 in the County area and 7 Mutual Aid calls. Acadian transported 11, 6 from China Grove, 5 for the County. There were 14 EMS Calls for medical, three Motor vehicle collisions. Also 3 structure fires, 1 unauthorized burn and 3 activated fire alarms and 1 Assist the public call. A. PUBLIC HEARING TO RECEIVE TESTIMONY AND COMMENTS FROM MEMBERS OF THE PUBLIC ON THE MERITS OF AMENDING THE ZONING ORDINANCE BY REZONING PROPERTY LOCATED AT <u>7222 WHIPPOORWILL LN</u>, <u>Suite #1</u>; CHINA GROVE, TEXAS TO AUTHORIZE a <u>Warehousing and Storage</u> OPERATION, AS A CONDITIONAL USE <u>AMT Technologies</u>, *Inc.*" for warehousing and storage of OFFICE AND <u>MEDICAL EQUIPMENT & SUPPLIES</u>.

Hear testimony and or comments from the public

Louis and Darlene Castillo, owners of AMT addressed the council providing information about their operation explaining the location is used for office and storing of medical equipment such as oxygen

tanks. Mr. Castillo stated they keep approximately 100-150 during the summer and 225-250 at most. He added that they do some repair/maintenance on the tanks.

Fire Chief, Mike Winfield expressed his concerns regarding storage of the tanks. Reminding Mr. Castillo that Fire inspections will be required before a Certificate of Occupancy is issued.

B. B.Consider action on ORDINANCE 20-0702 PROHIBITING USE OF ENGINE BRAKES AND DECLARING SUCH USE AND RESULTING NOISE A PUBLIC NUISANCE; PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; PROVIDING FOR SEVERABILITY; PROVIDING A PENALTY; AND PROVIDING AN EFFECTIVE DATE

After council discussions including location of the 3 signs, Larry Keller made a motion to adopt the Ordinance Prohibiting Use of the Engine Brake within the city limits of China Grove. Margie Holisky seconded. All voted in favor.

C.Consider action to affirm appointment of Ryan Weeks as Reserve Peace Officer for China Grove Police Department

Chief Ralph Sramek introduced Ryan and his family. Ryan addressed council stating his experience as a Military Law enforcement officer since 2010 and his desire to continue the profession as a Peace officer of the State for China Grove PD. Frank Bennett made a motion to approve the appointment of Ryan Weeks as Reserve Peace Officer. Larry Keller seconded the motion. All voted in favor.

D.Consider action to authorize Mayor to enter contract with FORESITE GROUP for Engineering Services for the City of China Grove.

The City Administrator addressed the council stating negotiations with Foresite were in progress. Mayor Hajek provided additional detail noting we are waiting for adjustments to fees. Larry Keller made a motion to grant authorization for Mayor to contract with Foresite based on her good judgement. Frank Bennett seconded the motion. All voted in favor.
