STAFF REPORTS

Financial Report: Susan Conaway, City Administrator submitted and read the Financial Report. Dennis Parma, Public Funds Investment Officer submitted a Quarterly Report of City's financial status, stating that 60% of the city funds are currently held in CDs. Current interest rates and terms were discussed. Margie Holisky made a motion to renew \$75,000.00 of the SSFCU CD for a period not over 15 months at the best "obtainable rate" and that \$100,000.00 of the RBFCU Savings be deposited to a Certificate of Deposit for a term no longer than 15 months at the "best obtainable rate". Gail Beaver seconded the motion. All voted in favor.

Municipal Court written Report was not available. Susan Conaway reported the 1st In Person Court arraignment date held on June 10 under the approved Covid-19 Operating Plan was successfully implemented with the help of the China Grove Fire & Rescue team and additional China Grove Police Department officers.

Police Department: Written Report for the month of May was submitted by CGPD

Volunteer Fire Department: Fire Chief, Mike Winfield reported on a total of 20 calls for the month. Nine of those in the City limits, 3 in the County Area and 8 Mutual Aid calls. Acadian transported 3 in the City and 1 in the County area. Chief also reported communications with BCOEM regarding Covid-19 operating plans for China Grove business operations.

Animal Control/Code Compliance: Animal Control Officer, Lee Roy Rosales submitted written report for May that included 3 code compliance violations. Two violations for high grass and one non-disposal of trash. There were 4 animal control calls.
